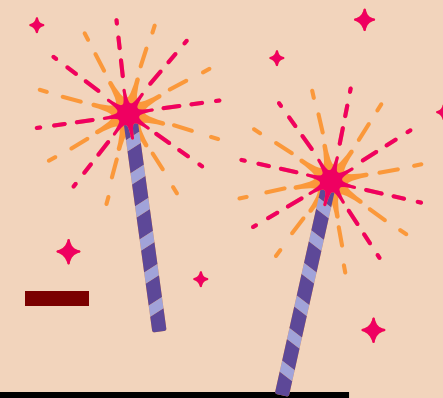

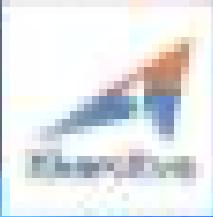
NRI Tax Services

Tax filing in India for NRIs

Understand Your Residential Status: You are considered an NRI resident for tax purposes if you are in India for 182 days or more during the financial year, or 60 days or more during the financial year and 182 days or more in the preceding four years.

- Identify Taxable Income:** As an NRI, you are taxable only on income that is earned or accrued in India.
- File Income Tax Returns:** If your taxable income exceeds the basic exemption limit, you must file an income tax return in India by July 31st of the assessment year.
- Claim Benefits Under DTA:** If applicable, claim benefits under the Double Taxation Agreement (DTA) to avoid double taxation on the same income.
- Submit Your Return:** File your return and ensure compliance with all reporting requirements.

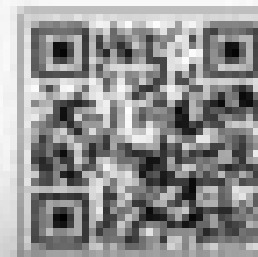
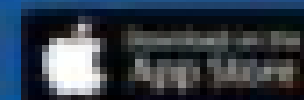
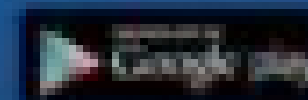
